## INSTRUCTIONS FOR COMPLETING THIS FORM

#### **GENERAL INSTRUCTIONS AND NOTES**

This form must be submitted by the ASN in respect of the driver that they wish to nominate for the FIA Institute Young Driver Excellence Academy (the Academy) regional selection event. The winner of each regional selection event will participate in the Young Driver Excellence Academy.

#### **Instructions for ASNs**

(1) Select your nominated driver, based on the selection criteria provided by the FIA Institute.

Preference should be given to drivers who have:

- Finished in the top 3 of a junior category or single make series.
- Finished in the top 5 of a national championship.
- Finished in the top 10 of a FIA championship.
- (2) Complete the nomination form in conjunction with the driver and submit it to the FIA Institute no later than 5 September 2014.
- (3) Please note that Part A must be completed by the driver and Part B must be completed by the ASN.

#### **Notes for ASNs**

- (a) The Academy is targeted at young drivers at the start of their competitive careers (refer to relevant FIA Institute selection criteria).
- (b) The Academy will generate a public benefit by: instilling in young drivers an understanding of, and developing an appropriate attitude in respect of, the highest standards of driver and road safety; and teaching young drivers the skills required to be qualified road safety instructors to enable them to educate the public.
- (c) An application submitted directly to the FIA Institute by a driver cannot be accepted.
- (d) ASNs must submit their nomination forms to the FIA Institute by 5 September 2014.
- (e) Nomination forms submitted to the FIA Institute after 5 September 2014 cannot be accepted.
- (f) The selection by the ASN of their nominated driver to be submitted to the FIA Institute will be a selection made at the discretion of the ASN and in which the FIA Institute will not be involved.
- (g) When considering drivers to attend the Academy, the FIA Institute, including through its third party service providers, will measure drivers against the selection criteria available on the FIA Institute's website, however, the final selection of drivers will be made at the discretion of the FIA Institute and the FIA Institute shall not be obliged to provide reasons for the selection or rejection of any driver at any stage of the process.

#### ADDITIONAL INSTRUCTIONS

Before completing this form, the ASN must read and understand the selection process and selection criteria located on the FIA Institute's website (<u>click here</u>). It is also recommended that the ASN read the best practice framework for the Young Driver Safety Programme, also located on the FIA Institute's website (<u>click here</u>).

The form must be completed in English. All questions marked with a "\*" MUST be completed.

In order to complete this form it is recommended that you have Adobe® Reader® - this will enable the ASN to complete the form electronically, save the form, and return it via email.
